[The Juncker Commission's ten priorities: State of play in early 2018](#)

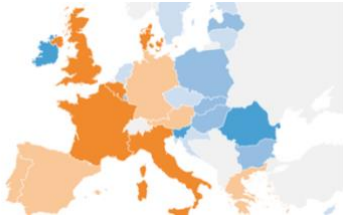
This latest edition of this six-monthly EPRS In-depth Analysis provides an up-to-date overview and detailed analysis of the state of play in delivery by the European Commission on each of the ten priorities which its President asserted when taking office in 2014. The paper aims to respond to growing interest in assessing progress towards the targets the Commission has set itself, and to identify areas where there are still difficulties, as the Commission enters its final full calendar year.



[Ten issues to watch in 2018](#)

This is the second edition of an annual EPRS publication designed to identify key issues that are likely to impact on the political agenda of the EU over the coming year. The challenges featured include: terrorism threats, the North Korean issue, the security challenges posed by disinformation, fake news and cyber-threats, the ongoing migration crisis and rising inequalities. Other

important policy areas covered are youth empowerment, the EU Budget, the future of the euro area, the run up to the European elections in 2019 and, last but not least, Brexit.



[Economic and Budgetary Outlook for the European Union 2018](#)

This study, the second in an annual series from EPRS, provides an overview of the economic and budgetary outlook for the European Union (EU) in 2018 and beyond. It summarises the main economic indicators in the EU and euro area, and their two-year trends. Economic projections point to robust growth, easing in the future, and falling unemployment. Risks are broadly balanced, but both internal and external challenges persist and may weaken economic recovery. A special 'economic focus' looks at industry and industrial policy in Europe, and provides an overview of various recent EU-level initiatives. The study also explains the annual EU Budget, and sets out the wider budgetary framework. Amounting to €160.1 billion, the 2018 EU Budget focuses on priorities such as promoting sustainable growth, creating employment, especially for young people, and addressing migration and security challenges.



[Demographic Outlook for the European Union](#)

Demography matters. The economy, labour market, healthcare, pensions, the environment, intergenerational fairness, election results and the EU's very place in the world are all driven by demography, as this study, the first in an annual series, shows. With the world population more than doubling since 1960, reaching around 7.3 billion today and expected to continue to grow strongly, passing 10 billion in 2055, the EU represents an ever-shrinking proportion of the world population. Its 500 million people represent just 6.9 % of the global population today (down from 13.5 % in 1960), and this is projected to fall further to just 4.1 % by the end of this century. The EU population is also ageing dramatically (in common with many other parts of the world), as life expectancy increases and fertility rates are lower than in the past. This has serious implications across a range of areas. Free movement within the EU and migration from third countries also plays an important role in shaping demography in individual Member States and regions. While, at the EU level, both men and women have seen their average life expectancy increase by over 10 years between the early 1960s and today, health data, although inconsistent, suggests that people are not necessarily living these extra years without suffering limitations to their usual activity.

[Composition of the European Parliament](#)

The European Parliament is due to discuss and vote on a proposal from the Constitutional Affairs Committee (AFCO) on the redistribution of seats for the 2019 European elections. As our 'At a glance' note explains, even before the prospect of UK withdrawal from the EU, the distribution of seats at the last election did not formally meet the condition of 'degressive proportionality' set down in the EU Treaties. Brexit, and thus the freeing up of 73 seats, provides the opportunity to adjust the current distribution of seats, taking account of demographic shifts. Moreover, 46 of the current UK seats would be held in reserve, either for a future transnational constituency or for possible further EU enlargement.

[Understanding artificial intelligence](#) (Podcast)

So called Artificial intelligence (AI) systems already permeate daily life: they drive cars, decide on mortgage applications, translate texts, create artworks, play games, and intervene in conflict zones. This Briefing explores the roots of the AI revolution that emerged from the combination of machine-learning techniques and 'big data'. It also explores the current limitations of these systems: they perform single tasks, can be biased and are opaque in their decision making. The development of AI systems requires adaptation of legal frameworks on the collection, use and storage of data. But more importantly, the key issue remains the level of autonomy given to AI systems to make decisions that could be life-changing. If the threat of a 'super-intelligence' able to self-improve and dominate humans remains unrealistic, AI systems are expected to impact on society, especially the labour market, and could increase inequalities.

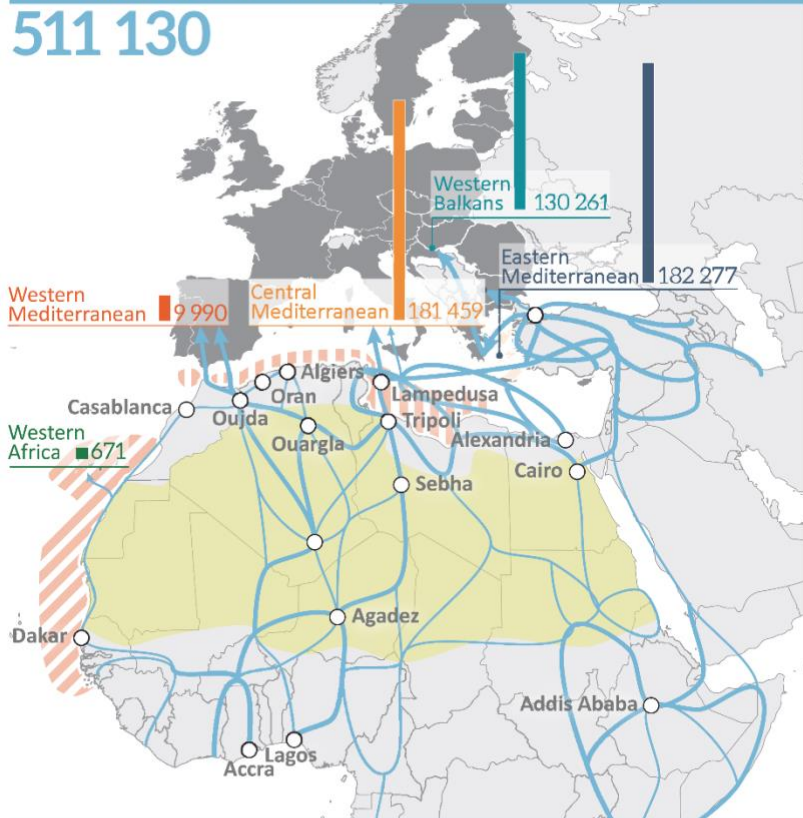

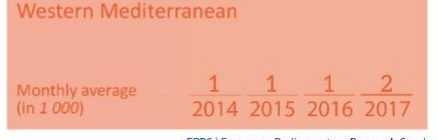
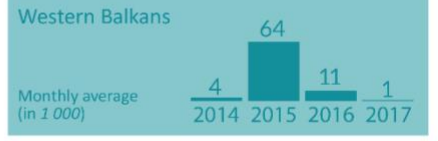
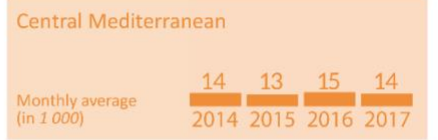
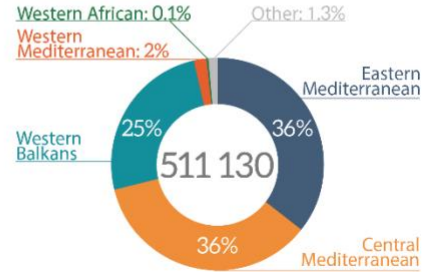
Detections of illegal border crossings in the EU (2016)
